Ms. Farrow provided an update on COVID-19 activity at THP. She shared the current inpatient COVID-19 numbers, including the vaccination status. Ms. Farrow also shared the scenario planning for COVID-19 preparedness for the fall and outlined THP's capacity planning underway in preparation. This includes system wide efforts and collaboration to enhance inpatient and ICU pediatric capacity. She indicated the approach to Wave 4 planning is aligned to THP's COVID-19 recovery taskforce priorities, which Ms. Farrow and Dr. Morra are co-chairing. Ms. Farrow provided an update on surgical volumes at THP and indicated that one of the recovery priorities is on safely returning surgical capacity. She highlighted that workforce stabilization and wellbeing is a top priority for THP's recovery stage with various initiatives underway.

Ms. Farrow reminded the Board that a Board Master Plan Education Session is planned for September and will be a valuable opportunity to level-set on project milestones and context to support decision making in the coming year. She indicated that THP continues to advance strategic projects including the Accelerated Long-Term Care (LTC) Build Pilot Project, with a meeting with the Minister of Long-Term Care booked later in the month to discuss terms related to schedule and cost.
