

Reportable Energy Consumption, Intensity and Greenhouse Gas Emissions

Ontario's broader public sector energy reporting initiative (Ontario Regulation 25/23) aims to enhance energy efficiency and sustainability in public sector organizations across the province. It requires participating organizations to report energy consumption data, benchmark their performance, and develop Energy Conservation and Demand Management (ECDM) plans to reduce energy use and greenhouse gas emissions. This initiative is part of the government's broader efforts to reduce energy consumption, greenhouse gas emissions, and overall environmental impact.

According to Ontario Regulation 25/23, Ontario public agencies must report their annual energy use and greenhouse gas emissions to the Ministry of Energy each year by July 1. The regulation applies to municipalities, municipal service boards (water and sewage operations), post-secondary institutions, hospitals and school boards. The regulation requires reporting to be done using ENERGY STAR Portfolio Manager (ESPM) electronic reporting system. In 2023, BPS organizations reported on energy consumption for 2021, in 2024 BPS organizations reported on energy consumption for calendar years 2022 and 2023. Usage data for all forms of energy consumed (for example, electricity, propane, natural gas, diesel, fuel oil) by properties need to be reported for the reporting year.
